- 5. Crossing Closure and Settlement Agreement [CC&SA]
  - 1. Recitals section, item 1.: On May 20, 2019, INRD petitioned the Board to close a railroad grade crossing located at Indian Hill Road, DOT# 292 193F, in Brown County, Indiana, pursuant to Indiana Code section 8-6-7.7-3.2.
  - 2. To this same point, in § 2.03 [of the CC&SA] INRD states that the 2019 petition-to-close will be withdrawn only after BC takes steps to satisfy terms given in § 2.01 [of the CC&SA] meaning that the 2019 petition had not been withdrawn and was active for almost a year without being acted upon by BC.
