2. OTHER EXPENSES OF THE OFFICE OF THE COUNTY AUDITOR.

Clerk – Election- additional appropriation of \$4000.00 from the General fund 1000 pursuant to IC 3-7-12-22.

Where the Circuit Court Clerk serves as voter registration officer, the clerk is entitled to per diem compensation **under subsection (b) or (c).** 

**(b).** This subsection applies to the circuit court clerk of a county in subsection **(a)** that contains not more than one hundred thousand (100,000) registered voters. The county shall pay at least the following to the circuit court clerk of the county: (1) Two thousand dollars (\$2,000.00) not later than July 1 of each year in which a primary election is held. (2) Two thousand dollars (\$2,000.00) not later than December 31 of each year in which a general election is held.
